

TRANSFER COMMITTEE REPORT ON AGT-2026 AT SRO-MADURAI


In pursuance of RO Chennai Office Letter No. 51-A-22015/24/2025-ADMN (E-1529840) dated 02.03.2026 and as per RO Chennai O.O. Nos. 19(E), 20(E), 21(E), and 22(E) of 2026 dated 28.02.2026, the Transfer Committee for Group 'C' Staff of SRO Madurai was constituted vide Memorandum No. 57-A/22/11/17/2021-Admn.I dated 02.03.2026 and convened a meeting to examine the transfer requests and make recommendations in respect of officials who have completed their office tenure of five (5) years and tenure in sensitive posts of three (3) years.

Accordingly, the remarks and recommendations of the Committee are given in Annexure attached.


