1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover shall upload the supporting documents to prove his eligibility for Relaxation.
3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
6. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023. [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.
7. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents

submitted.

8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

9. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- If number of technically qualified bidders are only 2 or 3.
- If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

Special terms and conditions-Version:1 effective from 24-07-2023 for category Locking Compression Plates (V2)

1. All Provisions of Drugs and Cosmetics Act, 1940 and Rules (including Medical Device Rule 2017) made there under as amended till date will always be applicable. This will include all notifications issued by Central Drugs Standard Control Organization (CDSCO), Ministry of Health & Family Welfare (MoHFW) and Department of Pharmaceuticals (DOP), Ministry of Chemicals & Fertilizers time to time in this regard.
2. The sellers are registered on GeM based on self-declaration of valid Drug License, product certification, test reports etc. However, buyers must check and validate the details at their end for all applicable licenses and certifications e.g., validity and authenticity/genuineness of drug license, product certification, manufacturer certification/licenses, test reports etc.
3. In case of authorized resellers/distributors, it will be the legal & regulatory liability of the manufacturer to ensure that their resellers/distributors are operating in compliance with all relevant laws and regulations and are properly licensed to sell the manufacturer's products, including verifying the validity and authenticity of drug license held by them.
4. The price offered by the seller/bidder shall not, in any case exceed the DPCO/NPPA controlled price or price fixed by State Government, if any. The seller must reduce the prices if there is any reduction in DPCO/NPPA ceiling price or price fixed by State Government, if any.
5. Evaluation:

Purchase order:

Payment:

- Ø Payment shall be made in Indian Rupees as specified in the contract in the following manner:
 - a. The payment towards the supply is subject to receipt of inspection note/performance certificate/items or sub items utilized by the user department with conformation to the purchase order placed quarterly.
 - b. Payment shall be made through GeM portal to the successful bidder for only that no. of items/sub items utilized by the user department.
 - c. The vendor should upload invoice in GeM portal for respective contract as per the quantity utilized.

Additional Terms and conditions:

1. The Dean ESIC MC & Hospital, Ludhiana will be at liberty to terminate the tender proceeding without assigning any reasons thereof. The bidder will not be entitled for any compensation whatsoever in respect of such termination.
2. No article shall be supplied to the hospital except on requisition in writing and signed by an officer authorized by him/her in writing to do so.
3. Bidders in their own interest shall ascertain the eligibility of whatsoever concessions and exemptions are eligible and applicable to the ESIC MC & Hospital, Ludhiana and shall advise the purchaser and quote accordingly.

NOTE:

- ∅ The delivery of the goods has to be made to the hospital strictly in accordance with the supply order & with the approved specification & within specified time. But if the delay shall have arisen from any cause such as strikes, lock-out, and fire accidents riots etc. which the THE DEAN, ESIC MC & Hospital, Ludhiana, may admit as reasonable ground for further time, the Dean may allow such additional time required by circumstances of the case.
- ∅ Implants used in surgery must be supplied with metallurgical report of said batch from concerned authority.
- ∅ **Bidder should quote for all implants (plates, screws and nail, bolt etc.) for each set should be quoted from same OEM to prevent compatibility issues. Any Bidder quoted items from different OEM for plates, screws, nail and bolts of same set shall be disqualified.**
- ∅ The manufacturer should have a valid CDSCO or BIS or CE certificate for the implant. The manufacturer should have valid Drugs Controller General of India (DCGI) license or US-FDA approval or CE certificate for the implant as applicable. ISO certification should also be attached.
- ∅ **The companies/ Distributors have to supply full set of instrumentation required for all the cases along with full range of tools and implants as per requirement of the department.**
- ∅ Instrument sets have to be provided free of cost in respect of implants purchased for orthopedic surgery one day prior to surgery against a Challan. The bidder shall be responsible to supply and to collect back the instrument set against receipt after the completion of surgery without any cost. Acknowledge will be provided by an authorized person in the orthopedic OT for receipt and return of instruments. No claim in respect of any damage to instrument during use or due to normal wear & tear shall be admissible. Failure to provide instruments as and when required will be considered as non performance.

- Ø Sometimes the specific size / measurement of an implant/item could only be determined by the surgeon in the operation theatre, due to individual variation in physical measurements of patients. The tendered firm/distributor should be willing to make necessary arrangements, in consultation with the concerned officer of the department, in such cases, so that the items within a range of sizes/measurements are available at operation to choose from. It is made clear that only those items which are selected and used in such cases are considered for procurement and the rest/unused items in such cases are to be taken back by the tendered firm/distributor at their own risk and cost.
- Ø **The company representative who has knowledge of implants should be available in the OT for any assistance to the surgeon about the Instrumentation and implants for all the cases as and when required by the department of Orthopedic. - Ø The Company should provide technical Assistance and training of the hospital staff as and when required. The company should be able to provide more than one set in a day if required.
- Ø Companies supplying revision implants should provide instruments for removal of well fixed implants & cements.
- Ø **The companies should provide a good working standard drill/saw system (Including Saw blades) for the cases at their own cost along with the instrumentation if required as per requirement of the department.**
